- *Groups Exercise* Building Common Ground (when communicating with your constituents)
  - What are the barriers when communication and what are the possible solutions? Kevin will share the dialogue results with the entire staff senators.

# External Affairs, Ashley Schwed

The External Affairs committee met with Mark Dearmon, SEANC. They disused the following items:

- Governor's Budget, 2% raise for State Employees or \$800 & one time \$500 bonus
- House Bill 540-\$2,400 across the board raise for all state employees
- House Bill 497-2% COLA raise for retirees
- Increase of Health Care Premiums
  - $\circ$  \$25 premium on the 70/30 plan
  - $\circ$  \$50 premium on the 80/20 plan
