Through established and growing partnerships and a shared commitment to the University's mission of teaching, research, and engagement, the faculty, staff and students recognize that bringing their voices together advances that mission and the entire community at NC State. Creating an environment where voices of each constituency are considered throughout the decision-making process.

Supporting avenues of open communication and accountability.

Recognizing that each governing body complements, rather than competes, with each other.

Understanding that collectively our voices are strengthened when unified as one. Let it be recognized on this date, <u>Wednesday</u>, <u>March 19</u>, <u>2014</u>, that these governing bodies commit to continually work toward successful shared governance at North Carolina State University.
